This panel will explore the dire and sometimes unintended consequences of family separation due to orders of protection and incarceration in New York State, and examine legislative solutions to remedy this and protect family bonds. Panelists will examine how legal tools, and policies and practices claiming to protect can instead inflict harm, including de facto evictions, disrupted caregiving, trauma to children, lost employment, and increased exposure to both the criminal legal system and immigration enforcement. We will highlight the racialized and gendered nature of these harms and call for a reimagining of justice that prioritizes due process and family stability.


